2. Executive summary

2.1. General progress

The project is being implemented in line with the schedule, with minor modifications connected with extension of the scope of some activities. Information on the implementation of the project is published regularly on the project website as well as in WIGRY quarterly (issued by the Wigry National Park), which is nationwide. According to application dates, milestones have been completed since the start of the project: "Signing the contract for the project" - action E.1, "Completion of the amphibious culverts" - Action C.4, "Conference "-Action E.6 and" Completion of land redemption "- Action B.1.

Since the last report (May 31, 2015), two project deliverables have been obtained that have already been reported as achieved - this concerns Valuation survey (Action A.1) and Notarial Acts of Land Purchase and Sale Agreements (Action B.1). These changes are due to the extension of these activities. Copies of additional valuation surveys and notarial acts are enclosed in Appendixes 1 and 2 to this Report (copies of previous valuation surveys and notarial acts were included in the previous progress report).

During the reporting period, four activities were completed: Land redemption preparation - Action A.1, Land redemption - Activity B.1, Organization of educational classes - Activity E.7 and Organization of workshops - Activity E.8. However, it is planned to extend the scope of action of E.7 and E.8, which will involve the extension of deadlines. So, in fact, only two actions (A.1 and B.1) were completed. It is also planned to increase the range of other activities that have already been completed (C.6, E.1, E.6). A detailed description of these changes is described in Chapter 5. Other activities are implemented as planned.

2.2. Assessment as to whether the project objectives and work plan are still viable

All the goals of the project are still valid and achievable. Planned actions have been largely completed and others are still feasible. By expanding the area from which the Impatiens

glandulifera plants are removed (C.3), there is a real possibility of limiting the size of the population of this species in the Wigierska Mainstay area to such a level that the native plant species could compete successfully with this alien stranger. The planned increase in the scope of some activities will also contribute to the achievement of the project's previously planned objectives.

2.3. Problems encountered

During the reporting period, the project was running smoothly and without problems. There are currently no threats to the implementation of individual actions or the achievement of the strategic objective of the project, which is to protect endangered species and habitats in the Natura 2000 "Wigierska Mainstay" area.

3. Administrative part

3.1. Description of Project management

During the reporting period, the project management rules did not change, although the composition of the Project Management Team changed. From 1 September 2015, Tomasz Janecki, technical project manager, was replaced by Aleksandra Mackiewicz, from 1 April 2016Anna Rynkiewicz, assistant manager of the project was replaced by Łukasz Olędzki. From 1 May 2016, Agnieszka Jankowska, assistant of the project financial manager was replaced by Marta Arciszewska. These changes were due to health considerations (in the case of Anna Rynkiewicz) and changes of employment (in other cases). During the reporting period, the Project Management Team implemented the following actions:

- coordinated and monitored the preparation of land purchases from the private owners (task A.1), purchase of private land (B.1), bushes removing (task C.1) and mowing of overgrowing open areas (C.2), removal of Impatiens glandulifera (C.3), construction of culverts for amphibians (task C.4), monitoring (D.1), implementation of information and education boards on selected activities (E.3), project website creation (E.4) organization of the conference (E.6), organization of learning activities (E.7), organization of workshops (E.8), networking with other projects (F.2) and monitoring of project progress (F.5);
- On 23-24 July 2015, at the headquarters of Wigry National Park, he organized a monitoring visit by Stanisław Tworek, representative of the External Monitoring Team.
- organized a study trip to Italy; Between March 28 and April 4, 2016, three people took part in the trip to Italy, where they visited the two LIFE-funded projects LIFE08 NAT / IT / 000372 and LIFE08 NAT / IT / 000326;

- organized on 21 May 2016 together with representatives of LIFE12 NAT / PL / 000063 Natura 2000 Day;
- Organized the meetings of the entire Project Management Team, which discussed the current work and set a timetable for specific actions for the future;
- monitored the project budget and timetable for implementation of the actions envisaged.

3.2. Organigramme of the Project team and the Project management structure

Diagram of the project management structure has not changed in relation to the objectives of the grant application, and therefore placed in a report in its original form.




Diagram 1. Project management structure

3.3. Reports delivered since the start of the project

Since the beginning of the project implementation, three reports have been submitted to the European Commission: Inception Report - prepared for the period 01.10.2012-30.06.2013, MidTerm Report - prepared for the period 01.10.2012-30.11.2013 and Report from Project progress (Progress Report) - prepared for the period 01.10.2012-31.05.2015. The Inception report was accepted by the European Commission (the letter of 9.08.2013) with the main comments on the purchase of land - excluding 4 plots of redemption plans and website

management - lack of full English version. All the EC remarks were taken into account - the purchase of land belonging to the Suwałki Commune was abolished and the texts on the website of the project were add to achieve the full English version. The mid-term report was accepted by the European Commission (the letter of 11.04.2014) with minor comments, which were taken into account by the Project Management Team. The progress report was accepted by the European Commission (letter of 14.08.2015) with minor remarks concerning the need to send the EC: copies of the land registry entries for the final destination of the purchased parcels for the nature conservation purposes, a copy of the list of participants, a copy of the report From the first stage of financial audit of the project and the detailed plan for the use of savings resulting from the project, with justification. Considering the Commission's comments to this report, we include the documents that were lacking in the previous Report (Attachments 3, 5 and 9).

3.4. Extension of the project duration

The project does not require an extension of the deadline implementation.

4. Technical part

The project is being implemented in the area of the "Wigrska Mainstay" characterized by high flora and fauna richness, which results from the varied sculpture of the area and associated mosaic of diverse habitats. This area is an important site for the occurrence of many species of plants and animals, both local and national. The project concerns the protection of selected elements of the natural environment, with particular emphasis on species and habitats covered by the Natura 2000 network. Its main objective is to protect endangered species and habitats in Natura 2000 "Wigierska Mainstay".

4.1. Actions

A. Actions Preparatory action, elaboration of management plans and/or of action plans

4.1.1. Action A.1 Preparation of the land redemption

The Action has been completed.

Actual deadline: III quarter of 2016

In the reporting period, the last Valuation survey was estimated for the plot with a total area of 1,9316 ha, which was the basis for the valuation of land and the start of price negotiations

with its owner. This plot is located in Leszczewek, in the area of "Wigry Mainstay" and includes valuable natural areas located in the vicinity of Błotniste Lake (in this area there is a large population of the *Leucorrhinia pectoralis* (code 1042), *Lycaena dispar* (1060) and *Bombina bombina* (1188). The deadline for the implementation of this action was extended due to the planned redemption of additional land from the pool of funds saved in the project. The last valuation was made in April 2016. A total of 41 estimates were made for 65 plots. A copy of the valuation surveys is attached as Annex 1 to this Report (other copies of the documents were sent to the EC together with the previous Progress Report).

4.1.2. Action A.2. Preparation of technical documentation, obtaining a building permit for the construction of manure tanks and manure concrete slabs.

The whole activity was described in the mid-term report and also the products of the activity were passed along with it. In the reporting period, the action was no longer continued.

4.1.3. Action A.3. Preparation of technical documentation and obtaining the building permits for the construction of culverts for amphibians

The whole activity was described in the mid-term report and also the products of the activity were passed along with it. In the reporting period, the action was no longer continued.

B. Purchase of land

4.1.4. Action B.1. Land redemption

The Action has been completed

Planned start date: IV quarter of 2012

Actual start date: I quarter of 2013

Planned deadline: II quarter of 2014

Actual deadline: II quarter of 2016

During the reporting period a plot of 1.9316 ha was purchased. The purchased plot is located in the Natura 2000 area, its purchase price was based on market conditions (the price was determined on the basis of the real estate appraisal made by the appraiser and negotiated with the land owner) and was purchased according to the project's assumptions.

Purchase of this plot resulted from the need to protect the complex of natural habitats ("Mountain and lowland peat bogs, sedges and mosses" - code 7230, "Central European and sub-continental marshes Galio-Carpinetum and Tilio-Carpinetum" code 9170 and " Poplar

albae, Populetum albae, Alnenion glutinoso-incanae, spring algae - code 91E0), located around a small water reservoir (Błotniste Lake) .The plot is almost directly borders the first two habitats (7230 and 9170). Partly includes the riparian habitat (91E0). All of these habitats are dependent on high groundwater levels. Particularly valuable is the basic peat bog, which belongs to the group of habitats that have been disappearing in recent years or significantly worsen its condition. The reasons for this include drainage meliorations as well as lack of mowing and descaling. There is a large population of the Leucorrhinia pectoralis (code 1042), the Lycaena dispar (1060) and the Bombina bombina (1188). The park plans to take measures to maintain the condition of groundwater, including mowing and cutting down the saplings and shrubs. All purchased land is designated for wildlife conservation purposes, which is appropriately marked (entry of irrevocable land allocation for the nature protection purposes) both in notarial act of land purchase and sale and in land and mortgage registers. The postponement of the termination date involved the planning of additional land from the pool of resources saved in the project. These funds came from other budget categories (including Equipment and Other Costs), but their transfer to the Land Purchase category does not result in a significant change within the meaning of art. 15.2 of the Common Provisions.

The total area of 71.2617 hectares from the 68 hectares planned for the project was purchased from private individuals.

The copy of the notarial act is enclosed in Annex No. 1 to this Report. (copies of all previous acts were included in the previous Progress Report).

C. Concrete conservation action

4.1.5. Action C.1. Bushes removing

The action is implemented

Planned start date: IV quarter of 2013

Actual start date: III quarter of 2013

Planned deadline: IV quarter of 2017

During the reporting period, the process of bushes removing was completed in the protected areas: Mikołajewo, Lipniak, Krzywe, Leszczewek, Gawarzec i Powały, on the total area of 4,55 ha. Since the beginning of the project, 12.49 hectares have been covered by the project, with 20 hectares planned in the project. In the next periods (IV quarter of 2016 and IV quarter of 2017), it is planned to carry out this action on an area of 11.89 hectares (the contractor of these treatments is already selected as part of the tender). In total, the bushes removing process will be performed on an area of 24.38 hectares, ie 4.38 hectares larger than originally

assumed. Financial sources to increase the scope of this action will come from the budget of

this action - from unused funds.

4.1.6. Action C.2. Mowing

Planned start date: IV quarter of 2013

Actual start date: III quarter of 2013

Planned deadline: IV quarter of 2017

In the reporting period mowing was carried out in the Protected Areas: Krzywe, Mikołajewo,

Leszczewek, Gawarzec, Lipniak i Krusznik; total mowing area- 28,76 ha. From the beginning

of the project, the treatment covered 54.67 ha of 120 ha planned in the project. In the next

periods (IV quarter of 2016 and IV quarter of 2017), it is planned to carry out this treatment

on an area of 65.95 hectares (the contractor of these treatments is already selected as part of

the tender). Total mowing will be performed on an area of 120.62 hectares, which is 0.62

hectares larger than originally assumed.

4.1.7. Action C.3. Impatiens glandulifera removal

The action is implemented

Planned start date: II quarter of 2013

Actual start date: II quarter of 2013

Planned deadline: III quarter of 2017

In the reporting period, further work (3rd and 4th season) related to the removal of Impatiens

glandulifera from the "Wigierska Mainstay" area was carried out. These works were carried

out on an area of 54,155 hectares in 2015 and 55,405 hectares in 2016, on land plots located

along Czarna Hańcza and Wiatrołuża rivers, on the banks of the Wigry Lakes (in the western

part thereof) and Czarne near Bryzgiel, and on the Peninsula Monastery - east side of it. The

need to increase the area from which Impatiens glandulifera is removed (originally planned

for an area of 30 hectares) resulted from the rapid spread of this species to neighboring areas

and the discovery of new, previously overlooked sites of this species. Enlargement of the

scope has been previously accepted by the Commission (ENV.E3 MM / jv ARES (2013)

2858557 dated 09.09.2013 and ENV.E3 MM / jv ARES (2012) 1148545 dated 11.04.2014).

4.1.8. Action C.4. Construction of culverts for amphibians

The action has been completed

Progress report LIFE+

The whole operation was completed according to the project schedule and described in the

MTR and PR1. In the reporting period, the action was no longer continued.

4.1.9. Action C.5. Construction of manure tanks and manure concrete slabs

The action has been completed

The whole action was completed before the deadline, and manure slabs and manure concrete

slabs were put into operation. The action is described in the MTR. In the reporting period, the

action was no longer continued. Monitoring of the action results indicates that the built-in

concrete slabs and tanks are properly used by the owners of the farms and function properly.

4.1.10. Action C.6. Construction of footbridges

The action has been completed

The entire operation was completed according to the schedule and described in the MTR. In

the reporting period, the action was no longer continued. However, it is planned to expand the

scope of this activity by using the financial resources saved in the project. It is planned to

reconstruct the viewing platform, located above the dystratic tank Suchar IV. This platform

was built many years ago on the peat moss surrounding the reservoir. This results in a strong

impact of tourism on vegetation and animal habitats, including several species of peat bogs,

sundews and dragonflies. It was necessary to reconstruct the wooden structure, replace the

construction material and move it away from the slab towards the mineral edge. The

implementation is planned for the first quarter of 2017. A detailed calculation of the extension

of this scope is provided in Annex 10. Financial resources to extend the scope of the action

will come mostly from the same budget category (Infrastructure) and from the Personal

category. The expected transfers of funds do not entail a significant change within the

meaning of art. 15.2 of the Common Provisions.

D. Monitoring of the impact of the project actions

4.1.11. Action D.1. Monitoring

The action is implemented

Planned start date: II quarter of 2013

Actual start date: I quarter of 2014

Planned deadline: IV quarter of 2017

During the reporting period studies on butterflies were continued, including the Lycaena

dispar, on selected areas for mowing and bush removal (invertebrate monitoring), plant tests

including peat bog, Loesel, low birch, common greyhound, blue peat, peat violet,

Dactylorhyza incarnate - ochroleuca type and Dactylorhiza fuchsii (plant monitoring), conducting researches on Impatiens glandulifera at the areas covered by its removal (plant monitoring), rosemary studies on areas affected by the construction and modernization of tourist footbridges (monitoring of effects related to the construction and modernization of tourist routes). Physicochemical studies of river waters, over which manure slabs and manure tanks were built (monitoring of the environment quality of Ophiogomphus cecilia and Unio crassus occurrence), amphibian studies along the roads where the systems of culverts for amphibians were planned (vertebrate monitoring) and corncrake studies on selected surfaces for mowing and bush removal (vertebrate monitoring). According to the plan all research results will be developed in the form of reports after the end of the whole operation.

4.1.12. Action D.2. Evaluation of the socio-economic impact of the project

Action is implemented:

It was decided to accelerate the start of this action, which should bring a better quality of the report. The contractor of the action who submitted the best bid in the tender referred to the Art. 70.1-70.5 of the Civil Code. The contractor has already begun to develop research methodology, including the development of questionnaire content and the scope of in-depth individual and group interviews.

E. Public awareness and dissemination of results

4.1.13. Action E.1. Publishing the information folder about the Project

Action completed.

The action was described in the Inception Report and the action product has also been forwarded within. In the reporting period, the action was no longer continued.

However, it is planned to expand the scope of this activity by using the financial resources saved in the project. It is planned to prepare and issue a book describing the results of the project. The only publication planned earlier in the project was a small folder that informs about the project's implementation (it was released at the beginning of the project). In our opinion it is advisable to consolidate the results of the project, which are undoubtedly very interesting and valuable, also in the form of a literary position. The implementation is planned for the third quarter of 2017, so that the publication will be printed on the final project

conference. A detailed calculation of the extension of this scope is provided in Chapter 5. The

financial sources for extension will be from the same budget category (External).

"News" tab, which resulted in no display of the transferred text (with graphics). This error has

already been fixed and the text is visible on the page. We will do our utmost to translate the

texts into English as quick as possible.

According to the project schedule the action is not implemented yet.

4.1.18. Action E.6. Organization of the conference

The action has been completed.

The action was described in Progress Report 1. At the request of the Commission (a letter of ENV E3 IM / AmC / ip Ares (2015) 3398987 of 14.08.2015) a copy of attendance list of conference participants was attached to this Report (Attachment 5). In the reporting period, the action was no longer continued.

However, it is planned to extend the scope of this activity by using the financial resources saved in the project. It is planned to organize a final conference of the project. It will be an opportunity to present the results of the project to the participants of the conference, but at the same time it will be a platform for sharing experiences both in terms of active nature conservation and project management. The idea of organizing a conference to summarize the project was born as a result of numerous questions related to the project of the interested parties, including representatives of other projects of the LIFE Program. We are convinced that the presentation of concrete, very interesting results of the project at the public forum will bring tangible benefits to current natural beneficiaries of the projects and the potential ones. The implementation of the measure is foreseen at the turn of the third and fourth quarter of 2017. A detailed calculation of the extension of this scope is provided in Chapter 5. The financial sources for extension will come from the same budget category (External).

4.1.19. Action E.7. Organization of educational classes

The action has been completed.

During the reporting period four educational classes took place. Activity reports and attendance lists are attached as Attachment 6 to the Report. On 28-31 July 2015, under the Summer Academy of Nature, classes were devoted to: flying organisms, mainly birds and trees. 34 people took part in the building of the management of the Wigry National Park. On 3-4 August 2015 in the seat of the Wigry National Park in Krzyw, there were further classes from the Summer Academy of Nature. In two days, 34 participants took part in the study of nature using a microscope, magnifier or binoculars. On February 2-5, 2016, in the headquarters of the Wigry National Park in Krzywe, the Winter Academy of Nature took place. This time the main theme of the class was "Young Naturalist's Laboratory". During the course, attended by 41 children with tutors, a workshop was held: "The inhabitants of a drop of water from Wigier", "In the land of bees and honey", "What in the head squeaks, or how people and animals perceive the world", and - "Fire - element." On 25-28 July 2016, on the

area around the Environmental Education Center in Slupie, the Summer Academy of Nature held, where 36 participants took part in it, with the theme "Journey to the interior ..." One day the participants traveled inside the meadow, then into the water and into the depths forest. Since the beginning of the project, 10 educational classes have been conducted, out of 10 planned in the project, with 350 participants. However, it is planned to expand the scope of this activity by using the financial resources saved in the project. Very high interest in the educational activities carried out within the project led us to plan two additional winter science classes (in the first quarter) and the Summer Academy of Nature (in the third quarter) in 2017. It turned out that the form of teaching activities used in the project is an excellent way to communicate the knowledge about nature, the methods of learning and protection. Extremely high involvement of participants (often whole families) and problem solving indicates that it is worth pursuing also in the last year of project implementation. It is planned that 30-50 people will participate in every class. A detailed calculation of the extension of this scope is provided in Chapter 5.

4.1.20. Action E.8. Organization of workshops

Action has been completed.

During the reporting period, seven workshops took place. Workshop reports and attendance lists are attached as Annex 7 to the Report. On August 8, 2015 in Krzywe, workshops for farmers and residents of "Wigry Mainstay" took place. The theme of the workshop was the protection of wild bees. Workshops consisted of the intimate and the field. The workshop participants first got acquainted with bee biology and ecology, with particular emphasis on the importance of this group of insects for the natural environment. During the practical part, under the guidance of an instructor, they performed constructions - so called "Cottages for bees". In the field part they have visited the educational trail "Forest", with wild beehive stations - wild beehives cut in the pine trees and hanged up ones. The meeting was attended by 30 people.

On September 26, 2015, another workshop was organized, this time for tour guides and people involved in tourism. Participants in the workshop mainly represented active guides from Podlaskie Voivodeship and teachers working with children and youth with various degrees of disability. The meeting was attended by 35 people. The main topic of the workshop was an opportunity to learn about the possibilities of exploring nature and the closest surroundings for the blind people. Participants were able to learn how blind people can perceive the surrounding reality and how to interact with such people. At the field session,

elements of the tourist infrastructure limiting tourist pressure in the area of Natura 2000 "Wigierska Mainstay": a bridge on the Łysocha peninsula, viewing platform at Powały and Bartny Dół and a platform on the Słupiańska bay were presented. Part of the trip was also a short visit to the modernized Environmental Education Center, where the guides learned about the educational background and offer of the Center's activities. On November 13, 2015, workshops for teachers took place at the headquarters of the Wigry National Park in Krzywe. The meeting was attended by 35 people - teachers of different levels of teaching - mainly primary schools and junior high schools, but also kindergartens. The workshops concerned, among other things, the rules of bird observation, NGO projects on birds that schools can take part of it, events integrating bird observers available online, free education materials on birds - keys, atlases, guides, scenarios, work cards, birds' voices - what to look for, how to recognize selected species of birds, work with pupils with the use of the birds' voices - practical activation exercises. In addition, games to motivate students to learn about ornithofauna were presented.

On May 14, 2016, at the Environmental Education Center on the Słupia Bay at the Wigry Lake, workshops for teachers were organized. "Why in the forest is dead wood?" The workshop was attended by a 30-person group of teachers, mainly teaching from the upper primary, middle and high school classes. The workshops were divided into two thematic blocks, one dealing with the concept of biodiversity and introducing the second part of the workshop, which specifically addressed the role of dead wood in enriching biodiversity in forest ecosystems.

On May 20, 2016, workshops for tourist guides were held. These were away workshops - mostly in the Wisztyniecki Regional Park (Lithuania). 10 people took part in the 10-hour workshop - tour guides, teachers, tour operators, tourism industry representatives, hotel and agrotourism owners, employees of the Suwalski Landscape Park and the Wigry National Park. Participants of the workshop were acquainted with the natural and cultural values of the Wisztyniec Regional Park, the protection activities and the principles of access to the park for education and tourism. During the field session the protected areas and the tourist infrastructure of the park were presented.

On May 21, 2016, workshops for farmers and residents of Natura 2000 "Wigierska Mainstay", concerning invasive species of plants of foreign origin, were held during the Natura 2000 Day celebration. During the workshop, 30 participants discussed in details about issues such as the impact of alien species on the environment, the occurrence of foreign invasive plant species in Poland and the area of the "Wigry Mainstay", the identification of

selected invasive species of plants of foreign origin, methods of their combat in protected areas and in households, ornamental plants - native species as substitutes for alien species and the code of responsible gardener conducting.

On October 22, 2016, further workshops for teachers took place - this time mainly teachers of primary schools took part. The workshop, whose motto was "Natural experiments in practice", was attended by 30 teachers. The main aim of the workshops was to: learn educational tools to help diversify scenarios of natural activities, to learn about the methods of nature experiments fictionalization, to develop the ability to use the research method, to learn how to adapt the educational space to active learning, to learn how to use the space of the Wigry National Park to implement the basis of the program in natural science teaching. Paweł Jaskólski and Tomasz Ruszkowski, experienced animators of the Copernicus Science Center, known as the "Heveliuses of Science", were leading the workshops.

Since the beginning of the project, 15 workshops have been carried out, out of 15 planned in the project, involving 470 people. It is planned to extend the scope of this activity by using the financial resources saved in the project. Extensive interest in workshops and the need to educate local communities have led us to plan for three additional workshops to be carried out in the second, third and fourth quarter of 2017. Additional workshops result from the local community's need for practical information on how to participate in active nature conservation. They are a good platform for the transfer of knowledge and practical application in the protection of the natural environment. It is planned that 30 people will participate in each workshop. A detailed calculation of the extension of this scope is provided in Chapter 5.

During the reporting period several meetings with representatives of other LIFE projects took place. On 30 May - 4 June 2015, the third foreign study visit was held, with five planned in the project. Five employees of the Wigry National Park took part in a business trip to Italy and Slovenia, where they visited two EU projects implemented by the LIFE program. The purpose of the trip was to establish contacts and exchange experiences with the LIFE Program (LIFE06 NAT / SI / 000069 and LIFE11 NAT / IT / 000094). In addition, representatives of two other LIFE projects - LIFE12 NAT / PL / 000034 and LIFE12 NAT / PL / 000063 - participated in the trip. It was also an excellent opportunity to exchange the experience gained during the implementation of EU projects by three Polish beneficiaries. Participants met with representatives of the LIFE06NAT / SI / 000069 "Presihajoce Cerknisko Jezero" project in the headquarters of the Regional Park in Cerknica (Notran Rugijski Park) and the representatives of the management of LIFE11 NAT / IT / 00094 "SOS Tuscan Wetlands" project. The report of the trip is Annex No. 11 to the Report.

Another study visit took place on 28.03-03.04.2016. Three employees of the Wigry National Park took part in the trip to Italy. The purpose of this visit was to familiarize ourselves with the projects implemented in the area of Matera (ARUPA - URGENT PROTECTION ACTIONS FOR AMPHIBIANS AND REPTILES IN THE MATERA GRAVINA - LIFE08 NAT / IT / 000372) and in the Gargano National Park (FAUNA DI MONTENERO - URGENT PILOT ACTIONS FOR AMPHIBIANS , REFERENCE AND CHIROPTERA OF

MONTENERO - LIFE08 NAT / IT / 000326). The report of this trip is Annex No. 12 to the

Report.

On May 21 2016, the Wigry National Park, in partnership with the "Man and Nature"

Association - implementing the project "Protecting amphibians in Natura 2000 areas in north-

eastern Poland", organized the Natura 2000 Day - a picnic for all interested parties. In Stary

Folwark village, at the Wigry Museum, you could see LIFE projects, takeing part in games

and natural events, and in workshops dedicated to invasive plant species of foreign origin. A

brief report of this event is enclosed in Annex 14.

On June 1-3, 2016, employees of the Wigry National Park participated (as the co-organizer)

in the conference. " Amphibians - significance, threats and protection" held in Gawrych Ruda

in the Wigry National Park. It was a conference that concluded the implementation of the

LIFE12 NAT / PL / 000063 project. During the conference, in which Representatives of

national parks, landscape parks, NGOs, regional environmental management boards and

universities have delivered two papers on the results of our project: "Active amphibians in the

Wigry National Park" (Anna Krzysztofiak, Lech Krzysztofiak) and "Amphibians in the

education of the Wigry Park National "(Joanna Adamczewska, Katarzyna Łukowska). During

the field session, participants of the conference were able to familiarize themselves with the

construction of the passages for amphibians in Wiatrołuża and Krzywe. At the end of the

discussion panel, which held on the last day of the conference, participants were able to watch

the film "Friends of the Frogs", shot in the cycle "Dances with nature". The film presented the

results of the implementation of two amphibious protection projects funded by the European

Union LIFE Fund (LIFE11 NAT / PL / 000431 and LIFE12 NAT / PL / 000063).

Out of the five planned foreign study visits, only one remained unrealized; its implementation

was postponed for the second quarter of 2017. Due to the planning of events related to

contacts with representatives of other LIFE projects, it is proposed to postpone the completion

of this activity for the fourth quarter of 2017.



One new action was launched in the reporting period - D.2. Assessment of socio-economic impact of the project. C.1, C.2, C.3, C.6 (extended range), D.1, D.2, E.1 (extended range), E.4, E will continue in the next reporting period. E.4, E.5, E.6 (extended range), E.7 (extended range), E.8, F.1, F.2, F.3, F.4 and F.5. The next report will be the final report whose deadline, according to the application form, is due in 4th quarter of 2017. Due to the need to submit a financial audit report together with the final report, its deadline for submission to the Commission was postponed to 1st quarter of 2018 as presented in the MTR, which has already been approved by the Commission. All other activities planned in the project will be completed before the project completion date.

4.3. Impact

An assessment of the impact of ongoing or already completed actions on the population of plant and animal species and on the natural habitats covered by the project is the subject of separate actions planned in the project (Action D.1). The results of this monitoring will answer the question whether the planned protective measures have been planned and carried out properly and whether they bring the expected environmental effects. Detailed results of monitoring will be known only at the end of the project, ie in the fourth quarter of 2017. However, it has already been established that activities such as " Impatiens glandulifera removal " (C.3), " Construction of culverts for amphibians " (C.4) or "Construction of footbridges" (C.6) significantly affect protected nature. After four seasons of removal of invasive species of foreign origin (Impatiens glandulifera), the size of its population was significantly reduced in the area of "Wigry Mainstay". In the areas covered by these treatments, the occurrence of indigenous plant species, that effectively competing with foreign visitors, is emerging. Many positions of rare and endangered species have been rescued from destruction by alien elements. Also the lower passages (culverts) for amphibians are very effective. Previous monitoring results clearly indicate that these devices, in their construction sites, reduce the mortality of amphibians by almost 100%. Very satisfactory results also brings the change of the footbridge location around the dystrophic tank and building the footbridges on the selected sections of the tourist paths. The current impact of tourists on vegetation along these paths is minimized, and many of the species that have been under the high pressures are now rebuilding their populations.

4.4. Outside LIFE

The implementation of the project has resulted in some activities that go beyond the schedule of works and expenditures of the project. These include organizing in Stary Folwark the Natura 2000's Day (described in Section 4.1.24, Activity F.2, Creating a Network with Other Projects). Also, the method of combating *Impatiens glandulifera*, developed in the project, was the basis for the other projects development concerning the protection of native nature against invasive alien species. They have been used, among others, to plan activities under several projects submitted to the Forest Fund of the Forest State.

For actions A.1, A.3, B.1, C.3 and F.2, higher costs were incurred than was originally assumed. Sometimes these exceedances were small, such as in case of actions A.1 or F.2. The reasons for the higher costs of actions A.3, B.1 and C.3 have already been reported in the midterm and progress reports 1. Three of the above activities have already been completed (A.1, A.3, B.1), and the other two Are underway (C.3 - remained the last season of *Impatiens glandulifera* removal, F.2 - last remaining study visit). In the reporting period, action D.2 will also incur higher costs than originally planned (€ 1238.00). This is the result of a tender to determine the contractor of this action. Activities A.2, C.4, C.5, C.6, E.1, E.2, E.3, E.6, E.7, E.9, E10 and F.6 have also been completed, which generated savings (these savings were already covered by higher costs in actions A.1 and A.3). In the case of completed activities: C.6, E.1, E.6, E.7 and E.8, it is proposed to extend their scope.

C.6 Construction of footbridges - it is proposed to reconstruct the viewing platform located above the dystrophic tank Suchar IV. The platform was built many years ago and is located directly on the peat marsh, surrounding the water reservoir, on the hiking trail around the "suchar". The need to preserve this tourist development facility, while at the same time protecting the reservoir with the surrounding rug of live and peat plants floating on the water surface, with many valuable natural plant species (several species of peatmoss, sundews) and animals (dragonflies, water beetles), force them to rebuild the structure and move it away from the rug towards mineral bank. The detailed costs of the reconstruction of the platform and the construction project are attached as Annex 10 to the Report. The estimated cost of construction works is € 128263 (€ 29860). Proposed deadline: 1st quarter of 2017.

E.1 *Publishing the project information folders* - It is proposed in this activity to develop and publish a book presenting the most important results of the project. So the book will concern, among others: conservation of amphibians, protection of native nature from invasive plant species, protection of groundwater and surface waters from pollution from animal breeding and protection of open spaces, their fauna and flora, from overgrowing. Costs of 20 000,00 PLN $(4656 \, \oplus)$ include printing - full color, paper - chalk 150 g, cover 4+4 on paper 300 g on both sides foil, binding, translation of a comprehensive English summary.

E.6 *Organization of the conference* - It is proposed to organize a conference summarizing the project implementation at the turn of September and October 2017. The conference, which was organized two years earlier, focused mainly on the assumptions of the project, and will

now outline the concrete results of the various activities. This will be a great opportunity to exchange experiences on active nature conservation between LIFE beneficiaries as well as academics and practitioners. It is planned that the conference will last for 3 days (including one day off) and will be attended by 80 people. The cost of such an event is as follows: food - 80 people x 3 days x 120 PLN = 28 800,00 PLN; Accommodation - 80 people x 3 nights x 120 PLN = 28 800,00 PLN; Conference materials - 90 pieces x 60 PLN = 5400,00 PLN; Transportation during field session − 1 000,00 PLN; Total - 64 000,00 PLN (14 666.51 € at the current rate).

E.7 Organization of educational activities - it is suggested to organize and conduct educational activities from the Winter Academy of Nature series and the Summer Academy of Nature (one of each kind). Extending the scope of this activity results from the very high interest of the local community (the younger one) of the educational activities carried out within the project. The cost of two classes (usually several days), for 30-50 people at one meeting, is as follows: teaching aids - 2 classes x 750 \in = 1500 \in , fees and educational materials - 2 classes x 875 \in = 1750 \in ; Total 3250 \in . The classes are scheduled for the first and third quarter of 2017.

E.8 Organization of workshops - it is proposed to organize and carry out three additional workshops. These classes are very popular and there is a need for three more workshops. Their costs are as follows: fees for lecturers - 2 people x 3 workshops x 350 \in = 2100 \in , training materials - 30 sets x 3 workshops x 12.5 \in = 1125 \in , catering - 30 people x 3 workshops x 12.5 \in = 1125 \in ; Total 4350 \in . The workshop is scheduled for the second, third and fourth quarter of 2017.

For the full activities C.1, C.2, D.2, E.4, F.1, F.4 and F.5, which are under way, contracts are signed and the amount of savings can already be determined at this stage (This amount is € 25971,84). Significant savings were also generated in other activities that have already been completed (A.2, C.4, C.5, E.1, E.2, E.3, E.6, E.7, E.8, E.9, E.10, F.6). As shown in the table on page 25, the sum of the remaining funds in the project is € 239 906,27. After subtracting from this amount the obligations resulting from the contracts already signed, the amount of approximately € 120 000 remains. This amount will cover the costs of extending C.6, E.1, E.6, E.7 and E.8, which are estimated at € 56,782 and higher than those planned for some activities, such as F2.

None of changes in the costs of the individual actions will result in a change in budget categories above the 10% and 30000 €, meaning no significant change within the meaning of art. 15.2 of the Common Provisions.
